

**State Medical Board of Ohio
Formal Action Report –April 2016**

Please find below a summary of actions taken or initiated by the State Medical Board of Ohio in April 2016 and an update of Board matters pending or decided in courts as of April 13, 2016.

PRE-HEARING SUSPENSIONS

MEDIODIA, Manuel H., M.D. (#35.029526)—Cincinnati, Ohio

Pursuant to Section 4731.221, Ohio Revised Code, medical license automatically suspended by operation of law upon doctor being adjudged by a probate court to be mentally ill or mentally incompetent. Notice of Automatic Suspension effective 4/14/16.

CITATIONS/PROPOSED DENIALS

BOLGER, Paul Matthew, MD (#35.125336)--Davenport, Iowa

Based on prior action by the Iowa Board of Medicine which issued a citation and warning, ordered doctor to pay a \$10,000 civil penalty, ordered completion of a professional ethics program and prohibited doctor from engaging in the practice of telemedicine without the prior written approval of the Iowa Board of Medicine. Notice of opportunity for hearing mailed 4/14/16.

CROFT, Lisa Louise, D.O. (Applicant)—Westchester, Pennsylvania

Based on the doctor's statement that she has not been engaged in the practice of osteopathic medicine and surgery as an active practitioner for more than two years. Notice of opportunity for hearing mailed April 22, 2016. (Non-disciplinary).

DARRAH, Casey Dave, M.D. (#35.127592)—Toledo, Ohio

Based on allegation that doctor did not successfully complete the graduate medical education requirement for licensure and medical license was mistakenly issued. Notice of opportunity for hearing mailed 4/14/16. (Non-disciplinary)

HALL, Adam Patrick, DO (#34.008707)--Tampa, Florida

Based on convictions in the Court of Common Pleas of Lawrence County, Ohio in which doctor pled guilty to Attempted Tampering with Evidence, a fourth degree felony and Possession of Criminal Tools, a fifth degree felony; allegations that doctor violated the conditions of limitation placed by the Board upon his certificate to practice; and allegations that his acts, conduct or omissions occurring after 3/14/07 and before 3/14/12 constitute making a false, fraudulent, deceptive, or misleading statement in the solicitation of or advertising for patients; in relation to the practice of osteopathic medicine and surgery; or in securing or attempting to secure any certificate to practice or certificate of registration issued by the Board. Notice of opportunity for hearing mailed 4/14/16.

MENKES, Alan Lewis, DO (#34.001775)--Murietta, California

Based on prior action from the Oregon Board of Medical Examiners which limited the doctor's license to office-based practice and based on the allegation that the doctor made a false, fraudulent, deceptive, or misleading statement in the solicitation of or advertising for patients; in relation to the practice of osteopathic medicine and surgery; or in securing or attempting to secure any certificate to practice or certificate of registration issued by the Board. Notice of opportunity for hearing mailed 4/14/16.

SONG, Won Geel, MD (#35.040064)—Dublin, Ohio

Based on allegations that in the care of 14 specified patients, the doctor's acts, conduct and/or omissions occurring on or after 11/30/11 constitute a violation of the Board's rule with respect to the Standards and Procedures for Review of OARRS. Notice of opportunity for hearing mailed 4/14/16.

SUTTON, Ernest Loran, MD (#35.096129)--Export, Pennsylvania

Based on prior action by the Virginia Board of Medicine which issued a license to practice medicine and surgery and issued a reprimand. Notice of opportunity for hearing mailed 4/14/16.

HALL, Adam Patrick, DO (#34.008707)--Tampa, Florida

Order vacating the April 1, 2013 Order of Summary Suspension and dismissing without prejudice the April 1, 2013 Notice of Opportunity for Hearing granted by the Board on 4/13/16.

CAPUTO, Jacquelyn Marie, MT (#33.017799)--Oregon, Ohio

Massage therapy license revoked. Based on the finding that massage therapist is unable to practice according to acceptable and prevailing standards of care by reason of mental illness or physical illness. Order effective 4/14/16.

CARDINAL, Traci Lee, PA (#50.003064RX)--Springfield, Ohio

No further action taken on license to practice as a physician assistant. Based on the finding that from April 2010 to December 2012, the physician assistant practiced as a physician assistant but failed to have a Board-approved supervision agreement in place. Order effective 4/14/16.

LEIBOLD, Jennifer Elaine, PA (#50.001562)--Springboro, Ohio

Application for valid prescriber number granted and no further action taken on license to practice as a physician assistant. Based on the finding that from November 2009 to December 2012, the physician assistant practiced as a physician assistant but failed to have a Board-approved supervision agreement in place. Order effective 4/14/16.

MAUSER, Paul Joseph, MT (Applicant)--Moreland Hills, Ohio

Application for license to practice massage therapy permanently denied. Based on the massage therapy applicant's felony convictions of Theft, Attempted Safecracking, Burglary, and Grand Theft, and a finding that the massage therapy applicant made false, fraudulent, deceptive, or misleading statements in securing or attempting to secure any certificate to practice or certificate of registration issued by the Board. Order effective 4/14/16. (Journal Entry-No Hearing Requested).

POLING, Rodney Howard, DO (#34.001990)--Grosse Ile, Michigan

License to practice osteopathic medicine and surgery reprimanded. Based on prior action by the Michigan Board of Osteopathic Medicine and Surgery Disciplinary Subcommittee which reprimanded the doctor's license and imposed a fine. Order effective 4/14/16. (Journal Entry-No Hearing Requested).

STOUT, Michelle Ann, MT (Applicant)--Avon Lake, Ohio

Application to practice massage therapy permanently denied. Based on massage therapy applicant's plea of guilty to, judicial finding of guilt of, or a judicial finding of eligibility for intervention in lieu of conviction for felonies, specifically Complicity to Improper Handling of Firearm in a Motor Vehicle and Misuse of Credit Cards; plea of guilty to, judicial finding of guilt of, or a judicial finding of eligibility for intervention in lieu of conviction for misdemeanors of moral turpitude, specifically, Assault and Theft; making a false, fraudulent, deceptive, or

misleading statement in securing or attempting to secure any certificate to practice or certificate of registration issued by the Board; and the finding that the massage therapy applicant failed to cooperate in an investigation conducted by the Board. Order effective 4/14/16. (Journal Entry-No Hearing Requested).

TAYLOR, Thomas Edward, PA (Applicant)--Columbus, Ohio

Application to practice as a physician assistant denied. Based on the finding that the physician assistant applicant is impaired in his ability to practice according to acceptable and prevailing standards of care because of habitual or excessive use or abuse of drugs, alcohol, or other substances that impair ability to practice and that physician assistant applicant has failed to fulfill requisite conditions for eligibility to receive a certificate to practice as a physician assistant because he does not hold current certification by the National Commission on Certification of Physician Assistants and that he does not hold a master's degree or higher from an accredited program. Order effective 4/14/16.

WAITE, Jilian Althea, MD (#35.074883)--Centerville, Ohio

License to practice medicine and surgery reprimanded and subject to probationary terms, conditions, and limitations for at least one year. Based on the doctor's use of pre-signed blank prescriptions at medical practice, which is the commission of an act in the course of practice that constitutes a misdemeanor in Ohio. Order effective 4/14/16.

BELL, Arthur Howard, D.O. (#34.009030)—Cincinnati, Ohio

Permanent surrender of license to practice osteopathic medicine and surgery authorized by doctor in lieu of formal disciplinary proceedings pursuant to Sections 4731.22(B)(5) and (B)(26), Ohio Revised Code. Effective 4/13/16.

CELESTE, Ronald John, MD (#35.066648)—Mentor, Ohio

Permanent revocation of license to practice medicine and surgery authorized by doctor in lieu of formal disciplinary proceedings pursuant to Section 4731.22(B)(19), Ohio Revised Code. Effective 4/13/16.

LEWIS, Randal John, MD (#35.056399)--Lehi, Utah

Permanent revocation of license to practice medicine and surgery authorized by doctor in lieu of further formal disciplinary proceedings pursuant to Sections 4731.22(B)(5) and (B)(22), Ohio Revised Code. Effective 4/13/16.

PRATT, William Glenn, L.M.T. (#33.018565)—Columbus, Ohio

Permanent revocation of license to practice massage therapy authorized by massage therapist in lieu of formal disciplinary proceedings pursuant to alleged violations of Sections 4731.22(B)(10) and/or (B)(20), Ohio Revised Code. Effective 4/20/16.

SHERIDAN, Richard T., MD (#35.036782)—Cincinnati, Ohio

Permanent revocation of license to practice medicine and surgery authorized by doctor in lieu of further investigation pursuant to Section 4731.22(B)(26), Ohio Revised Code. Effective 4/13/16.

Permanent revocation of license to practice osteopathic medicine and surgery authorized by doctor in lieu of further formal disciplinary proceedings pursuant to Section 4731.22(B)(2), (B)(6), and (B)(20), Ohio Revised Code. Effective 4/13/16.
